CLASSICAL LANGUAGES

Major

Twenty-four semester hours in the languages and cultures of one of the following areas of specialization: Classics, Greek, or Latin.

1. Classics

Six hours of upper-division Greek

Six hours of upper-division Latin

Classical Civilization 375, Greek 365, or Latin 365

Nine additional hours chosen from Greek, Latin, [er] Classical Civilization, and Ancient History and Classical Civilization 325 or 378, including at least three upper-division hours

2. Greek

Twelve hours of upper-division Greek, including Greek 365

Twelve hours chosen from Latin, [and/or] Classical Civilization, and Ancient History and Classical Civilization 325 or 378, including at least nine in upper-division coursework

3. Latin

Fifteen hours of upper-division Latin, including Latin 324 and Latin 365

Nine hours chosen from Greek, [and/or] Classical Civilization, and Ancient History and Classical Civilization 325 or 378, including at least six in upper-division coursework

Classical Languages Honors Program

Majors who plan to seek special honors in Greek, special honors in Latin, or special honors in classics should apply to the honors adviser for admission to the honors program at least one full academic year before they expect to graduate. A University grade point average of at least 3.00 and a grade point average in Greek (for the Greek specialization), Latin (for the Latin specialization), or Greek, Latin, and classical civilization combined (for the classics specialization) of at least 3.50 are required for admission. Completion of Ancient History and Classical Civilization 378 or Classical Civilization 375 is highly recommended before applying for special honors. The requirements for graduation with special honors, which are in addition to the requirements of the major, are

- 1. Greek 679H, Latin 679H, or Classical Civilization 679H, Honors Tutorial Course, with a grade of at least A- in each half
- 2. A University grade point average of at least 3.00 and a grade point average of at least 3.50 in the coursework required for the major and for honors
- 3. Completion in residence at the University of at least sixty semester hours of coursework counted toward the degree

EXPLAIN CHANGE TO DEGREE PROGRAM AND GIVE A DETAILED RATIONALE FOR **EACH INDIVIDUAL CHANGE:** Historically, the Center for Mexican American Studies housed the MAS undergraduate degree program. With the founding of the Department of Mexican American and Latina/o Studies in fall of 2014, all degree programs transferred out of the Center and into the Department. While this has provided a tremendous boost to our institutionalization and visibility, the lack of change in the undergraduate degree program has proved very confusing to students. Thus, for practical reasons, we are petitioning to have the major moved out of the Ethnic Studies Degree category, and into it's own free standing degree in Mexican American and Latina/o Studies. We believe the change will boost our numbers from 42 to 100 majors by fall of 2016. The reasons for the change are as follows: 1) having the degree program match the department name addressing contemporary trends with millenials in a language that is relevant to contemporary Latina/o 2) populations preventing confusion for students about the role of the department as the degree-granting unit making the degree program more inclusive and broad to attract more majors demonstrating the robust nature of our comparative and transnational approaches to Latina/o 5) populations With departmentalization, we have already seen the benefits of how such changes impact our success. Having an autonomous freestanding major will only cement these efforts further. Our major numbers have increased from 19 to 45 and we have received several requests for a transcript-Recognized minor. With the change from Mexican American Studies (an ethnic-national designation) to Mexican American and Latina/o Studies (broader, ethnically diverse, relational approach to studying Latina/o populations and a Mexican American majority simultaneously), we will be able to better brand our program as a degree that trains students to become Latina/o serving professionals. [Majors who plan to seek special honors in sociology should apply to the honors adviser by October 1 for admission to the honors program the following spring; they should apply by April 1 for admission the following summer or fall.
