12. OTHER CERTIFICATE REQUIREMENTS:

All students are required to complete the following requirements:

- 1. At least nineteen credit hours of course work, to be distributed as follows:
 - a. *Foundation Courses*: Four-to-seven credit hours of foundation courses that introduce key concepts and skills/theories related to the interdisciplinary study of Ethics and Leadership. Students take the following courses:
 - i. Forum Seminar (one credit): BDP 101: Professional Ethics in Law, Business, and Medicine; BDP 101: Intro to Conflict Resolution and Peace Studies; or another course approved by the Ethics and Leadership faculty committee.
 - ii. Ethics and Leadership Foundation Course (three or six credits): ADV 378: Leadership and Ethics; CMS 322E: Communication Ethics; COM 301L: Intro to Comm & Leadership; P A 325: Advanced Seminar in Ethical Leadership; PHL 304: Contemporary Moral Problems; PHL 318: Introduction to Ethics; PHL 325K: Ethical Theories; R S 306C: Comparative Religious Ethics; or another course approved by the Ethics and Leadership in the Media faculty committee. Students must choose at least one course from this list; if they choose to take two courses from this list, they will only take 6 hours of strand courses.
 - b. *Connecting Experiences:* Six credit hours of coursework in undergraduate research and/or internships that connect students' Ethics and Leadership in Technology and the

- Media BDP to their major field. Connecting Experiences are designed to be individualized based on the student's interests and goals, and a variety of course numbers offered through the BDPs (BDP 320K, 320L, and 325K) and in departments across the University may be used. All students must write a 3-5 page essay reflecting on the experience, in addition to the academic requirements specified by the faculty member supervising the student and assigning a grade.
- c. Courses in a Strand: Six-to-nine credit hours of approved courses in a strand that allow students to focus their remaining BDP course work. Students will work with their BDP advisor and the faculty panel to design an interdisciplinary strand that allows them to pursue their interests, and at the same time exposes them to multiple areas of concern related to ethics and leadership in the media. The list of approved strand courses is maintained by the BDP office, and the faculty committee for the Ethics and Leadership in the Media BDP approves new courses that may count toward the certificate each semester. The committee may also approve student petitions to count unlisted courses on a case-by-case basis.
- 2. A 3-4 page integration essay in which students reflect on what they have learned and accomplished through their BDP experience. These essays will be reviewed by members of the BDP faculty panel.
- 3. Students must earn a grade of at least C- in each of the courses taken to fulfill BDP requirements and the cumulative grade point average in all courses counting toward a student's BDP certificate must be at least 2.0. All but one of the courses taken to fulfill BDP requirements must be taken on the letter-grade basis.
- 4. At least half of the required course work in the BDP certificate must be completed in residence at The University of Texas at Austin.
- 5. Completion of the requirements of a major.
- 13. GIVE A DETAILED RATIONALE FOR CHANGE(S): The curriculum for the Ethics and Leadership in the Media BDP certificate already includes courses that deal with ethical issues related to contemporary technologies. We would like to change the name of the certificate to reflect that the certificate allows students to explore not only media ethics, but also technology ethics more broadly. We believe this change will allow students whose interests may be in technology beyond the media to recognize this program as one that could be relevant for their interests and goals.

- b) Transcript-recognized undergraduate academic certificate programs must require a minimum of eighteen hours of certificate course work, but not more than twenty-four hours.
- c) At least half of the required coursework in the certificate program must be completed in residence at The University of Texas at Austin.
- d) A student may **not** earn a certificate in the same field of study as his or her major, and at least one course required in the certificate program must be outside the requirements of the major. However, courses in the certificate program outside the major may fulfill other degree requirements such as general education requirements or required elective hours.
- e) Students apply for transcript recognized undergraduate academic certificates at the time they complete their undergraduate degree or the certificate program, whichever comes later. Transcript recognition is awarded at that time.
